03. The item to be supplied under this contract shall be in strict conformity with Railway Stores **Specification Nos. 604, 605 & 565**, Sri Lanka Railways **Drawing Nos. 19773 A, 19773 B, 16324 A, 22664 & 20057 A** and Railway Conditions of Contract.
04. The supply is subject to pre-shipment inspection by an Inspector appointed by Sri Lanka Railways. Your kind attention is drawn in this regard to **Clause 25 of Section VI - Conditions of Contract** and **Clause 25.1 & 25.2 of Section VII - Contract Data**. Further, you should submit **01 Pair samples of each Fish Plates 80 Lbs., 04 Nos. Crossing Bolts & Nuts 7", 04 Nos. Coach Screw Ferrules for Concrete Sleepers and 04 Nos. Spring Washers 27.5MM** with required Test Certificates of physical and chemical composition of the samples within 01 (one) month from the date of L/C opened. The bulk production of the items shall commence only after the receipt of the acceptance letter issued by the SLR for the samples supplied.
05. The goods shall be delivered within **05 (five) months** from the date of opening of the Letter of Credit as stipulated in **Clause 12 of Section VI - Conditions of Contract & Clause 12.1 of Section VII - Contract Data**. Delay beyond the said delivery period, you are liable to pay Liquidated Damages as per **Clause 26 of Section VI - Conditions of Contract & Clause 26.1 of Section VII - Contract Data**.
06. Payment shall be made through an irrevocable and without recourse Letter of Credit established in favour of you as follows: -
- (a) **75%** of the contract price of the goods delivered less local agent's commission upon submission of the documents specified in **Clause 12.1 of Section VII - Contract Data** and in the Letter of Credit.
 - (b) **20%** of the contract price of the goods delivered less local agent's commission on arrival and acceptance of goods by SLR against a certificate of acceptance.
 - (c) The balance **05%** of the contract price of the goods delivered less local agent's commission on satisfactory completion of the warranty period or against a Bank Guarantee to the similar amount as per **Clause 15.1 of Section VII - Contract Data & Clause 27 of Section VI - Conditions of Contract**.
07. Please submit a Performance Bond covering 10% of the contract value as required in the Conditions of Contract, within **14 days** from the date of receipt of this **Notification of Award**. Your kind reference is requested to **Clause 17 of Section VI - Conditions of Contract** and **Clause 17.1 of Section VII - Contract Data** in this regard.
08. Goods shall be shipped by Ceylon Shipping Corporation Ltd. vessels and if no CSC vessels are available at the time of shipment, a waiver should be obtained from them to ship the goods by vessels other than the Ceylon Shipping Corporation Ltd. vessels.
09. Upon shipment of goods, please note to advise the dispatched particulars and forward copies of shipping documents, which are required in **Clause 12 of Section VI - Conditions of Contract & Clause 12.1 of Section VII - Contract Data**.
10. This Letter of Acceptance, Railway Conditions of Contract together with your offer dated **25.04.2025**, your acknowledgement to this Letter of Acceptance and the Performance Bond shall form a Contract binding on both parties until such time a formal contract agreement is executed.
